231. OVERNIGHT FIELD TRIPS AND STUDENT TRIPS ABROAD

1. Purpose SC 1361

The Board recognizes that teacher-chaperoned trips are educational experiences from which students can derive substantial benefit and generally approve such trips subject to the following conditions:

Overnight Field Trip

- 1. Such trips should have as their general purpose the fostering of education experiences.
- 2. Board approval for all trips must be granted before the planning for them reaches the stage of collection of money.
- 3. When a teacher plans a trip, the teacher must immediately apprise the principal and keep the principal informed of all arrangements.
- 4. Specific parental permission must be obtained.
- 5. Medical cards must be prepared and utilized.

Field Trip Abroad

- 1. It is restricted to students enrolled in grades 9-12.
- 2. Such trips should have as their general purpose the fostering of foreign language and/or foreign culture study.
- 3. When a teacher plans a trip abroad, the teacher must immediately apprise the principal and keep the principal informed of all arrangements.
